Caesar Ford Land Purchase

Mr. Dobney reported that there is no access to New Jasper Stationed Road. He reported people have purchased the adjacent property and donated 2.4 acres to GCP&T. They will sell us 5 acres for \$50,000 for a total of 7.74 acres. The Board would like GCP&T to create a list of reasons WHY TO BUY THE ACREAGE? We will explore this further at a later time.

Karohl Barn

Mr. Dobney stated they brought in a structural Engineer to check out the barn. The Engineer stated that the barn needed to be demolished, as it was deemed not structurally sound with rotting beams. GCP&T Managerial Staff members walked the neighborhood handing out letters to nearby neighbors to explain what was happening with the barn. GCP&T will be adding a shelter house using some of the same design features of the barn. Also they will be re-using the "quilt" on the side of the barn and will have electricity.

Spring Valley Thank You

Spring Valley Township has sent a "Thank you" note for the \$20,000 donation for Walton Park, Spring Valley.

Old Business

Special Projects Manager Charles Frazier updated the Board on the current special projects within the park system.

- 1. <u>Russ Nature Reserve:</u> Received first draft of a portion of the claim from insurance company. The house and trees are still being discussed by PERSO claims folks.
- 2. Pearl's Fen: Attended the Fairborn Zoning meeting on the subdivision extension.
- 3. <u>Fairgrounds Recreation Center Large Shelter: Rehabilitation:</u> The Shelter rehab is completed.
- 4. <u>Caesar Ford Campground:</u> Under contract with Schorr Architects for the feasibility study. Had kick off meeting and expect to have final report by late January early February.
- 5. Karohl Barn Review: Barn to be removed. Have notified the neighbors.
- 6. Mill Bridge Canoe Launch Grant: I have submitted the requested information to ODNR
- 7. New Building: The office area is under roof. The shop area will be under roof by the end of the week. The stone work is to start this week. Most of the interior walls are up. The footers for the front canopy were installed Friday.
