Ms. Stinson made a motion seconded by Mr. Finlay approving the request for the transfer of \$800.00 from line item 5334 (Grants to Non-County Entities) to line item 5315 (State Auditor's Annual Audit), and the transfer of \$500.00 from line item 5334 (Grants to Non-County Entities) to line item 5365 (Official Bonds), and the transfer of \$3,000.00 from line item 5334 (Grants to Non-County Entities) to line item 5389 (Telephone & Communication), and the transfer of \$5,000.00 from line item 5334 (Grants to Non-County Entities) to line item 5407 (Travel & Training), and the transfer of \$35,000.00 from line item 5334 (Grants to Non-County Entities) to line item 5504 (Equipment & Vehicles) out of the 0601 Park District fund.

Former Village of Yellow Springs Manager, Patti Bates. Ms. Bates reported on the Yellow Springs Food Forest, which was the brain-child of her and Boy Scout, Zenya Hoff-Miyazaki, who had been looking for an Eagle Scout project to do. Ms. Bates wanted to Thank GCP&T and stated she used the \$5,000 from GCP&T to make this happen and that it is now up and running full speed ahead.

Grant Payment to Owen's Place

Mr. Dobney reported that GCP&T has given the final installment payment of \$100,000 (a total of \$500,000 over the past 5 years) to Gussie Jones of Owen's Place, but plans to have a more formal big check ceremony in May at Owen's Place, inviting the public to attend.

Financial Statement

Mr. Dobney reported that from now on out the financial statement reflects the Park District's Cash Balance carried forward. It also shows the revenue and expenditures to date. Also reflected are the total encumbrances and ending balance. This report is updated monthly.

Audit Report

Mr. Dobney reported that the State Auditor's Report came back and it showed everything was in order for the audit period of 2017-2018.

Paddling Enhancement Grant

Mr. Dobney reported that Chuck Frazier is filing for a Paddling Enhancement Grant through the Department of Natural Resources Waterways section. The grant would be for the removal of the existing Porta-johns and replacing them with a New CXT restroom at the Narrows Reserve.

Old Business

Special Projects Manager Charles Frazier updated the Board on the current special projects within the park system.

1. Pearl's Fen:

- House has been sampled for asbestos. No Abetment Needed
- Scheduling for house removal.
- 2. Creekside Trail: James Ranch Bridge deck replacement to start mid Feb. Start date is Feb.24 with a completion date of March 3. Weather dependent
- 3. Spring Lakes Shelter rehab: Metal roof, add stone corner columns, pressure wash and seal exposed wood. Start in March.
- 4. Twin Towers Shelter Rehab: Metal roof, add stone to corner columns, pressure wash and seal exposed wood. Replace rotten fascia boards. Start in March.
- 5. Frank Seaman Shelter Rehab.: Metal roof, add stone corner columns, pressure wash and seal exposed wood. Replace rotten fascia wood. Start in March.
- 6. Clifton Lodge: Metal roof lodge and add gutters.
- 7. Ohio Erie Trail: Started brush removal.

Other Business

Mr. Dobney reported on the Program "Birds do it, Bees do it, Mammals do it too!" Clifton Lodge Feb 14th, 2020 630pm.
