NRAC Nomination

Mr. Dobney applied to be re-appointment to the District 11, Natural Resource Assistance Council (NRAC) board. Mr. Finlay signed a letter to support his re-appointment.

Special Projects Manager Charles Frazier updated the Board on the current special projects within the park system.

1. Cemex Reserve:

- Paved the entrance to park. It was damaged during the FEMA cleanup efforts during the tornado.
- 2. Narrows: Remove the vault from the old latrine to prepare the site for the new CXT restroom. Soil testing done at same time.

3. Bike Path Sealcoating:

All of the Little Miami Scenic Trail, the asphalt sections of the Wright Brothers Huffman Prairie Bikeway, Jasper Rd to the County Line on the Xenia-Jamestown Connector

- 4. Ohio Erie Trail: Site visit by KZF. Should have plans submitted to ODOT by early November, with fully approved plans by January 2021.
- 5. <u>Twin Towers:</u> Completed drainage work along the driveway to the main entrance.
- 6. Hobson:
 - Working with the County Engineer to open an access from the housing development to the north.
 - Paved the walk to the shelter, playground and the fitness tract.
- 7. James Ranch: Paved the gravel access from the parking lot to the bike path spur.
- 8. Koogler: Submitted a Clean Ohio grant for additional property next to park.

Upcoming events: Caesar Ford Ranger Classic 9/26/20 at Caesar Ford Park.
