New Business:

1. **Staff Changes:**

Director Dobney presented the board with staff changes happening among the employees at Greene County Parks & Trails and the new positions that may be coming available.

2. **Extreme Egg Hunt Update:**

Director Dobney presented the board with an update on the Spring Extreme Egg Hunt and the video that has gone viral that was created, by a participant, during the Extreme Egg Hunt. Also, Director Dobney, informed that Fox News and Yahoo have since reached out to us for a quote about the viral video.

3. **Sara Lee Arnovitz:**

An update was given to the Park Board about the negotiations happening with Center Point Energy concerning the pipe line at Sara Lee Arnovitz. An agreement has not yet been made.

Project Update:

1. **Spring Lake Bank Stabilization:**

The stabilization job is 95% complete. The final grade work is still to be completed.

2. **Spring Lakes Bridge:**

Demo of old bridge is complete. There are issues with the abutment on the park side.

3. **Hobson CXT Restroom:**

We are still waiting on the I.U. Stamped plans from CXT so we can proceed with final permitting.

4. **Little Miami Scenic Trail North:**

Corrected some bank erosion north of Brush Row Rd. Removed a log jam and cleaned culvert pipes out.

5. **Ohio to Erie Trail:**

Attended a pre-construction meeting with ODOT on the resurfacing project.

6. **James Ranch Pond:**

Received a proposal for onsite evaluations to determine the need for permits.

7. **Koogler Wetland Prairie Clean Ohio Grant:**

The Grant has been closed out and we have received our reimbursement check.

8. **Karohl Park/ Indian Mound CXT:**


CXT from Karohl park is moving to Indian Mound Cabin Lot.
