**Projects:**

Senior Projects Manager Charles Frazier updated the board on the current special projects within the park system.

1. Caesar Ford Campground:

- Work on the septic mound system is approximately 40% finished, this will cover the first and second phase.
- Electric for the site is well underway. The pedestals at each campsite are wired and all major runs are completed. Some of the components for the main electrical cabinet are scheduled for delivery the second week of August.
- Water / dump station are in.



- The building permit application for the CXT restroom / shower has been filed. The tentative date to be installed is mid-July.
- Gravel roads and campsite are going in along with topsoil respread to the sites. It is really taking shape and looking like a campground.

2. Parking Lots / Driveways: The Caesar Ford parking lot off of New Jasper Station Rd. is under construction.

3. Constitution Park: Poured a new pad down to the river to improve access to the river and improve the ability for Spring Valley EMS crews to launch their rescue boat.
