**Projects:**

Senior Projects Manager Charles Frazier updated the board on the current special projects within the park system.

1. Caesar Ford Campground:

- Work on the septic mound system is approximately 40% finished.
- Electric for the site is well underway. The pedestals at each campsite are wired and all major runs are completed. Some of the components for the main electrical cabinet are scheduled for delivery the second week of August.
- Water / dump station are in.
- We have the building permit application for the CXT restroom / shower. The tentative date to be installed is mid-July.
- Gravel roads and campsite are going in along with topsoil respread to the sites. It is really taking shape and looking like a campground.
- Phase I close out. Credits and contingency from phase 1 moved to phase 2 for work that was moved from phase 1 to 2.

2. Parking Lots / Driveways: The Caesar Ford parking lot off of New Jasper Station Rd. is completed.

3. McCalmont Park: The area for the parking lot has been OUPSeD. We will be starting on it soon.

4. Entrance Signs: New signs have been installed: Rear entrance to Fairgrounds Recreation Center, Scout Burnell Dog Park. Foundations and stone work have started at: Jacoby, Old Town, Arnovitz, Phillips, main entrance to Fairgrounds Rec Center. Target is to have all in by end of the year.

5. Twin Towers: Rotten wood on horse stalls have been replaced. Entire barn will be stained next week.


